Match play will begin on Wednesday, July 25th with 2 matches on Wednesday,  
2 matches on Thursday July 26th , and on Friday, July 27th there will be a 36 hole final match.  
32 players qualifying in each bracket. Subject to weather conditions.

#### **PRIZES**

A prize emblematic of the Junior Championship will be awarded the champion.  
Trophies will also be awarded to the champions and runners-up,  
semifinalists, and medallists in both flights.

#### **ELIGIBILITY**

Entries are open to amateur boys under age 19 (18) as of July 23, 2007.  
Contestants must be a legal resident of Wisconsin.  
Proper golf attire required, walking shorts allowed.

#### **ENTRY FEE**

Entry fee is \$60.00 and must accompany entry blank.  
All entries are subject to approval by the Tournament Committee in its  
discretion either before or during the Championship.  
Entry fee includes lunch Monday and Tuesday  
at the Johnson Park Club House, and Gifts for all competitors.

#### **DEADLINE**

THE FIELD WILL BE CLOSED AT 200 PLAYERS OR JULY 1th,  
WHICHEVER OCCURS FIRST. LATE OR INCOMPLETE ENTRIES ARE NOT ACCEPTABLE.
